Metra issued its Response to your January 9, 2019 request for *all train video from the Metra Electric Line near the 103rd and Cottage Grove stop on the evening on Monday, December 17, 2018 when 2 CPD officers (Conrad Gary and Eduardo Marmolejo) were struck and killed while responding to a shots fired call after the offender ran onto the tracks between 5:00 p.m. and 7:00 p.m.,* on January 10, 2019, via our FTP site.
