We are in receipt of your request for information pursuant to the Illinois Freedom of Information Act, 5 ILCS 140/1 *et seq.* ("**FOIA**")

On March 27, 2019, we received your request for 2018 crime statistics with regard to 1400 North Roosevelt Boulevard, Chicago, IL, including:

- a) whether any crimes were categorized as hate crimes in the following crime categories:
  - Murder/Non-Negligent Manslaughter
  - Negligent Manslaughter
  - Rape
  - Fondling
  - Statutory rape
  - Incest
  - Robbery
  - Burglary
  - Aggravated Assault
  - Motor Vehicle Theft
  - Arson
  - Domestic Violence
  - Dating Violence
  - Stalking
- b) if there were any incidents that were classified as hate crimes in the areas of:
  - Larceny
  - simple assault
  - Intimidation
  - vandalism or destruction of property; or
  - other crimes involving bodily injury
- c) For crimes classified as hate crimes, Requestor would like to know the category of prejudice for each hate crime according to the six categories they are required to report, which include:
  - race

- gender
- religion
- sexual orientation
- ethnicity
- disability; and

d) the statistics for arrests only for the following categories:

- Liquor Law Violations
- Drug Law Violations
- Illegal Weapons Possession
